Installation in powerpoint

1. Push USB mechanism into extra function hole.

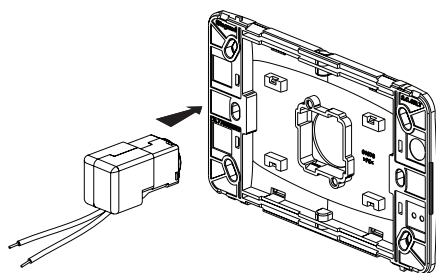
2. Connect wires with corresponding mains cables in the 'A' and 'N' terminals of double GPO.



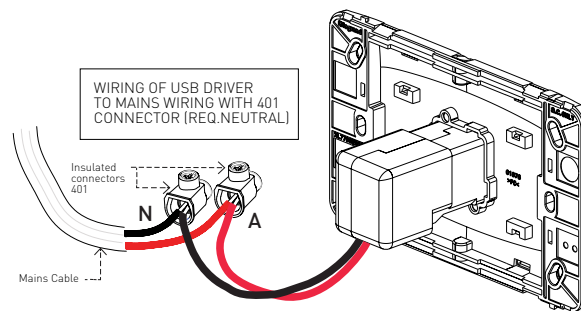
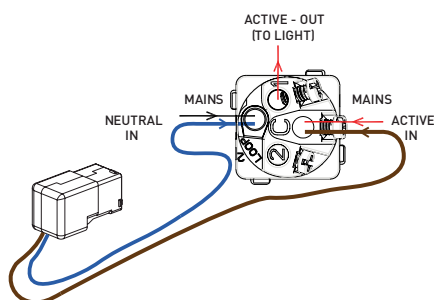
Note: All dimensions are in mm.

Installation in switch plates

1. Push USB mechanism into wall plate cut-out.

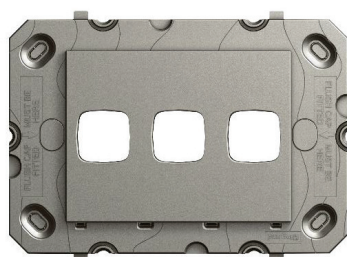


2(b). Configuration with USB and switch mechanism on the wall plate:

2(a). Configuration with USB mechanism on the wall plate: Connect USB module wires to the mains cable via insulated connectors (401 series - not provided) as per diagram above.

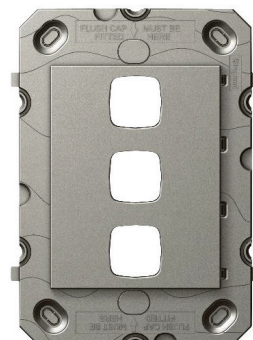
MULTI-GANG HORIZONTAL ORIENTATION



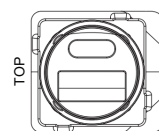
For vertical USB PORT positioning place USB charger facing the TOP.
